NOTICE OF FORTHCOMING INTERNAL AUDITOR ELECTIONS

Dear Colleagues in IBD!

Notice is hereby given, that the following ECCO position is open for election: **ECCO Internal Auditor 2024-2026 – 2 seats**

The ECCO Governing Board is implementing § 5.8.3 of the ECCO Statutes by giving notice at least 12 weeks prior to the General Assembly, taking place on Thursday, February 22, 2024 at ECCO'24 in Stockholm, Sweden where the election will take place.

Eligibility Internal Auditor: Any Regular Member of ECCO in good standing who has been an ECCO Member for a minimum of two years and currently does not hold any other ECCO function can stand for election.

Term of office: The term of Internal Auditor lasts two years, starts at the ECCO'24 Stockholm Congress, on February 22, 2024 and ends in 2026.

Tasks of Internal Auditor: The accounts of ECCO shall be audited by two Regular Members of ECCO (Internal Auditors) appointed by the General Assembly and monitored by an externally registered financial institution, qualified to act as a certified public accountant, if required by law.

Nomination process: Nominations can be made by any Regular Member. The person proposed has to consent to his/her nomination. Nominations must be sent in writing to the ECCO Office containing the following information: the name and affiliation of the person proposed, the name and affiliation of the proposer. The proposer and the nominee must be from different nations represented on the Strategic Council.

Application deadline is December 7, 2023
