NOTICE OF FORTHCOMING GOVERNING BOARD ELECTIONS

Dear Colleagues in IBD!

Notice is hereby given that the following position on the Governing Board of ECCO is open for election:

ECCO Treasurer 2024-2027

The ECCO Governing Board is implementing § 5.3.4.5 of the ECCO Statutes by giving notice at least 12 weeks prior to the General Assembly, taking place on Thursday, February 22, 2024 at ECCO'24 in Stockholm, Sweden where the election will take place.

Eligibility of Treasurer: Any Regular Member of ECCO in good standing who has served as an ECCO Committee member in the past and/or present can stand for election unless he/she holds a current position in industry or is a Regular Member who has served as Treasurer for one term.

Term of office: ECCO'24 Stockholm Congress, February 22, 2024 ending at the ECCO Congress in 2027, 3 years.

Nomination process:

Nominations can be made by any Regular Member and have to be supported by Regular Members: one proposer and two seconders. Both the proposer and seconders can be any Regular Member of ECCO or Y-ECCO Member in good standing, except members of the Governing Board, who are excluded.

Nominations must be sent in writing to the ECCO Office containing the following information: the names and affiliations of the person proposed, the proposer and the seconders. The proposer and seconders must both be from different nations. Voting will be by ballot, by simple majority rule.

Application deadline is December 7, 2023
