

NOTICE OF FORTHCOMING CLINCOM ELECTIONS

Dear Colleagues in IBD!

Notice is hereby given that the following position on the ECCO Clinical Research Committee (ClinCom) is open for election:

1 ECCO ClinCom Member 2025-2028

Tasks and responsibilities of ClinCom Members:

ClinCom's projects are devoted to improve the quality of IBD clinical research in Europe by acting as a broker advising and educating on the process, design, metrics, outcome measures and funding opportunities for clinical studies, in order to stimulate high-quality investigator-initiated studies (IIS) in IBD and to assist investigators developing IISs. The Committee interacts with regulators and industry in liaison with the Governing Board and is in charge of developing the programme of both basic and advanced EduCational Courses for Industry held at the ECCO Congress. Further, ClinCom designs the ClinCom Workshop as well as the School for Clinical Trialists.

By applying, you confirm you have read and agree to the Outline of Responsibilities. Please find it <u>here</u>.

Eligibility:

Applicants have to be established specialists in the area of IBD who are ECCO Regular Members of good standing (=ECCO Members 2024). However, they cannot apply for a term overlapping with a term of another Committee Member from the same institution.

In the following committees, a candidate can only serve one term: EduCom, SciCom, EpiCom, ClinCom, GuiCom.

Due to interdisciplinary status candidates can also apply for a second term to the following committees given a three-year break: H-ECCO, S-ECCO, P-ECCO, D-ECCO, N-ECCO.

A candidate can only serve on max 2 terms on ECCO Committees (consecutively or with a break in between).

Each Committee may devote 1 position within the Committee to a Non-European ECCO Regular Member. Please note that this candidate may not become Committee Chair nor Governing Board Member. Reimbursements remain at the European level.



Term of office:

The Committee Membership lasts 3 years, starts at the ECCO'25 Berlin Congress on February 20, 2025 and ends in 2028.

Nomination process:

A candidate may be proposed by an ECCO Member in good standing or self-nominated. Self-nominations need to be seconded by an ECCO Member in good standing. Forms for nominating candidates can be obtained from the ECCO Office or downloaded from the ECCO Website.

Application documents:

- a nomination form including a seconder
- a 2 page CV
- a list of 10 best publications
- and a letter of intent, explaining the suitability for the position in question.
 Please note that applicants may apply for up to 2 positions in different
 Committees, however, the letter of intent needs to include justification as well as a clear statement of the first and second choice.

Process of election:

Applicants are ranked on the below listed criteria. The candidates with the lowest (=best) rank will be recommended to the Operational Board and Governing Board for approval with at least one reserve name which is selected by rank order.

Election criteria:

- <u>Achievement</u> in the field of dealing with clinical trials (publications, scientific initiatives).
- <u>Declaration of intent</u> including a statement of the contribution that the candidate is able to make to ClinCom.



- <u>Experience</u> (for instance in programme development, project development, clinical trials).
- ECCO fosters diversity of representation. This is why scores are not the
 only consideration of every committee. Other important factors that have
 to be considered during the election process are regional and gender
 diversity, institutional affiliation within the committee, age, the degree to
 which the person will contribute to ClinCom tasks, academic expertise,
 team spirit, commitment, familiarity with ECCO, prior contribution to
 ECCO and future potential.

Election takes place during Committee Meetings in autumn. Elected candidates will be informed in due course.

Announcement of new Committee Members takes place during the General Assembly on February 20, 2025 at the ECCO'25 Congress in Berlin, which is also the official start of term.
