Notice is hereby given that the following positions on the ECCO Nurse Committee (N-ECCO) are open for election:

1 N-ECCO Member 2026-2029

Tasks and responsibilities of N-ECCO Members:

To unite nurse professionals interested or involved in IBD care in order to improve the quality of nursing care for patients with IBD by improving professional nurse education throughout Europe and beyond Europe's borders. To establish networking opportunities for specialist nurses in IBD that will improve multidisciplinary working and patient education. To coordinate and develop the course programmes of the N-ECCO School, N-ECCO Network Meeting and N-ECCO Research Forum. To provide further education to nurses through the ECCO IBD Nurse Education Programme, run in one country per course cycle. To continuously interact with N-ECCO National Representatives as well as to contribute content to the e-CCO Learning platform.

Eligibility:

Any established IBD Nurse who is an ECCO IBD Nurse Member in good standing (=ECCO IBD Nurse Member 2025) may apply or be proposed for the open position. However, they cannot apply for a term overlapping with a term of another Committee Member from the same institution.

Due to interdisciplinary status candidates can also apply for a second term to the following committees given a three-year break: H-ECCO, S-ECCO, P-ECCO, D-ECCO, N-ECCO.

A candidate can only serve on max 2 terms on ECCO Committees (consecutively or with a break in between).

Each Committee may devote 1 position within the Committee to a Non-European ECCO Regular Member. Please note that this candidate may not become Committee Chair nor Governing Board Member. Reimbursements remain at the European level.



Term of office:

The Committee Membership lasts 3 years, starts at the ECCO'26 Stockholm Congress on February 19, 2026 and ends in 2029.

Nomination process:

A candidate may be proposed by an ECCO Member in good standing or self-nominated. Self-nominations need to be seconded by an ECCO Member in good standing. Forms for nominating candidates can be obtained from the ECCO Office or downloaded from the [ECCO Website](#).

Application documents:

- a nomination form including a seconder
- a 2 page CV
- a list of 10 best publications
- and a letter of intent, explaining the suitability for the position in question. Please note that applicants may apply for up to 2 positions in different Committees, however, the letter of intent needs to include justification as well as a clear statement of the first and second choice.

Process of election:

Applicants are ranked on the below listed criteria. The candidates with the lowest (=best) rank will be recommended to the Operational Board and Governing Board for approval with at least one reserve name which is selected by rank order.

Election criteria:

- Achievement in the field of dealing with clinical trials (publications, scientific initiatives).

- Declaration of intent including a statement of the contribution that the candidate is able to make to N-ECCO.
- Experience (for instance in programme development, project development, clinical trials).
- ECCO fosters diversity of representation. This is why scores are not the only consideration of every committee. Other important factors that have to be considered during the election process are regional and gender diversity, institutional affiliation within the committee, age, the degree to which the person will contribute to N-ECCO tasks, academic expertise, team spirit, commitment, familiarity with ECCO, prior contribution to ECCO and future potential.

Election takes place during Committee Meetings in autumn. Elected candidates will be informed in due course.

Announcement of new Committee Members takes place during the General Assembly on February 19, 2026 at the ECCO'26 Congress in Stockholm, which is also the official start of term.
