

NOTICE OF FORTHCOMING Y-ECCO ELECTIONS

Dear Colleagues in IBD!

Notice is hereby given that the following position on the ECCO Young Committee (Y-ECCO) is open for election:

2 Y-ECCO Members 2026-2029

Tasks and responsibilities of Y-ECCO Members:

To support friendship and collaboration between young clinicians and scientists interested in IBD care, research and education. To support and participate in the educational and scientific activities of ECCO and to act as a platform for all young clinicians and scientists who want to contribute to ECCO and its activities.

By applying, you confirm you have read and agree to the Outline of Responsibilities. Please find it <u>here</u>.

Eligibility:

Applicants have to be established specialists in the area of IBD who are ECCO Regular Members of good standing (=ECCO Members 2025) under the age of 35. However, they cannot apply for a term overlapping with a term of another Committee Member from the same institution.

A candidate can only serve on max 3 ECCO Committees incl. Y-ECCO (consecutively or with a break in between).

Each Committee may devote 1 position within the Committee to a Non-European Y-ECCO Member. Please note that this candidate may not become Committee Chair nor Governing Board Member. Reimbursements remain at the European level.

Term of office:

The Committee Membership lasts 3 years, starts at the ECCO'26 Stockholm Congress on February 19, 2026 and ends in 2029.



Nomination process:

A candidate may be proposed by an ECCO Member in good standing or selfnominated. Self-nominations need to be seconded by an ECCO Member in good standing. Forms for nominating candidates can be obtained from the ECCO Office or downloaded from the <u>ECCO Website</u>.

Application documents:

- a nomination form including a seconder
- a 2 page CV
- a list of 10 best publications
- and a letter of intent, explaining the suitability for the position in question. Please note that applicants may apply for up to 2 positions in different Committees, however, the letter of intent needs to include justification as well as a clear statement of the first and second choice.

Deadline for submission is June 18, 2025

Process of election:

Applicants are ranked on the below listed criteria. The candidates with the lowest (=best) rank will be recommended to the Operational Board and Governing Board for approval with at least one reserve name which is selected by rank order.

Election criteria:

- <u>Achievement</u> in the field of dealing with clinical trials (publications, scientific initiatives).
- <u>Declaration of intent</u> including a statement of the contribution that the candidate is able to make to Y-ECCO.
- <u>Experience</u> (for instance in programme development, project development, clinical trials).



• <u>ECCO fosters diversity of representation</u>. This is why scores are not the only consideration of every committee. Other important factors that have to be considered during the election process are regional and gender diversity, institutional affiliation within the committee, age, the degree to which the person will contribute to Y-ECCO tasks, academic expertise, team spirit, commitment, familiarity with ECCO, prior contribution to ECCO and future potential.

Election takes place during Committee Meetings in autumn. Elected candidates will be informed in due course.

Announcement of new Committee Members takes place during the General Assembly on February 19, 2026 at the ECCO'26 Congress in Stockholm, which is also the official start of term.
