Open Rank Clinical Professor (IBD)

Position description:

The Department of Medicine and the Department of Pediatrics of McGill University invite applications for a full-time position as a member of the Contract Academic Staff as a clinician-scientist. This position is open ranked for Assistant Professor, Associate Professor, or Full Professor (Clinical). Professorial rank will be determined according to the candidate's qualifications and experience.

The successful candidate will be a clinician scientist with a research focus in pediatric or adult Inflammatory Bowel Disease (IBD). The ideal candidate's research program will seamlessly integrate into our current IBD research program, be open to collaborations that leverage local strengths in related research and clinical areas, and have a clear vision to bring our IBD research group to the next level.

The Departments will support an appropriate candidate for appointment to the Bruce Kaufman Chair in Inflammatory Bowel Disease. If appointed, this Chair will be assigned for a 3-year or 5-year term with potential for renewal, dependent upon the professorial rank of the candidate. The prospective Chair holder is expected to be a world class clinician scientist (or have clear potential for being a world class clinician scientist) in fundamental and/or clinical research in IBD. Salary will be according to the Quebec healthcare fee schedule.

The McGill University Faculty of Medicine and Health Sciences, located in the vibrant and multicultural city of Montreal, in the province of Quebec is a leader in academic medicine. Our educational and research missions support excellent and innovative research and clinical programs across our teaching hospitals.

Job Duties:

The candidate is expected to spend at least 50% of their time involved in research activities related to IBD. The remaining time will be dedicated to clinical duties such as pediatric to adult IBD transition clinic, outpatient clinics and attending coverage on consult and in-patient services. The candidate will also be expected to be involved in the teaching of medical students, residents, and fellows as required.

Qualifications and Education Requirements:

- Candidates must have an MD degree and must have completed training in Pediatric or Adult subspecialty in Gastroenterology, be Royal College certified (or equivalent) and hold or be eligible for licensure in Quebec.
- Candidates should hold the academic rank of Assistant Professor, Associate Professor or Professor. Research-intensive clinician scientists who currently hold FRQS awards may be eligible, but candidates may not also hold another Endowed Chair, Canada Research Chair, or other government funded Chair.
- ~~Expertise in transitional pediatric to adult or a cross-cutting research program involving different~~

methodologies or varying disciplines would be an asset.

- Research interests in sex and gender, or addressing IBD in otherwise diverse or marginalized populations, would be an asset.
