



**CALL for participation in the ECCO Position Statement:  
Definitions of histological abnormalities in IBD**

**Application deadline: January 27, 2022**

**Context:**

High quality microscopic examination of ileocolonic biopsies optimises the management of inflammatory bowel disease (IBD). Histology can confirm the diagnosis of IBD, assist with its subclassification (as ulcerative colitis or Crohn's disease), exclude its mimics, estimate disease extent, and detect complications such as CMV and neoplasia. There is also considerable recent interest in its ability to determine disease activity and severity and to refine the assessment of the mucosal response to drug therapy.

Selection of histological features by the pathologist for particular attention depends on the setting and the clinical question. For example, basal plasmacytosis, crypt distortion and crypt atrophy support a diagnosis of IBD, while granulomas and distribution of changes help to distinguish ulcerative colitis and Crohn's disease from one another.

Clinical trials require assessment of histological activity. Individual features that indicate activity include neutrophil cryptitis, crypt abscesses, neutrophil infiltration of the surface epithelium, erosion, or ulceration. Lamina propria neutrophils may also represent activity. Many of these features help predict response to therapy. Basal plasmacytosis and lamina propria eosinophils may also have value. However, clinical trials often use one of many composite scoring systems such as the Geboes score, Roberts index and Nancy index to assess histological activity/inflammation.

**Project aims:**

Despite strong reliance on histological features and scoring schemes for diagnosis, management, and clinical trials, there is often little information and/or little agreement on the basic definitions of histological abnormalities in IBD.

The many deficits and inconsistencies in histological definitions would benefit from specific attention, ideally by a group of experts and enthusiasts under the umbrella of a large IBD organisation using a process that is supported by the best available evidence. The result would be a new, comprehensive set of definitions of IBD histology in one publication from experts in pathology and gastroenterology.

The main aims of the project are:

- To identify all known definitions and criteria for each histological feature that may occur in IBD
- To create definitions of features where necessary
- To produce consensus ECCO definitions regarding the histological features of IBD
- To explore the reasons for and ways of reducing interobserver variability

WG3: Definitions of acute inflammation, erosion, ulceration, and eosinophil abnormalities

WG 4: Histological definitions and terms for disease distribution, disease categories, epithelial atypia/dysplasia, and activity

Workgroups prepare core messages as "Position Statements" which will be discussed and voted on in a plenary meeting to achieve consensus. After the final vote, the manuscript is finalised and published in the *Journal of Crohn's and Colitis* (JCC).
