

# ECCO Call for Participants in the update of the N-ECCO Consensus Statements on the European Nursing Roles in Caring for Patients with Crohn's Disease or Ulcerative Colitis (2025-2026)

## Deadline for submission is January 6, 2025

# Context

The landscape of Inflammatory Bowel Disease (IBD) management has evolved significantly since the last N-ECCO (Nurses-European Crohn's and Colitis Organisation) Consensus Statements, which were based on literature published before 2018. The past decade has seen a proliferation of high-quality research and emerging trends that necessitate an update to these guidelines. IBD nurses have traditionally played a critical role in the multidisciplinary care of patients with IBD, providing education, support, and managing symptoms. Telemedicine, e-health, and m-health platforms are a reality that must be progressively integrated in IBD nursing care. IBD nurses are increasingly involved in these digital health initiatives, which allow for more frequent monitoring, remote consultations, and personalized care plans. These technologies can improve patient outcomes, but they also require nurses to develop new competencies and adapt to changing workflows. With the growing complexity of IBD treatments, including biologics and small molecules, nurses are also more involved in medication management, monitoring side effects, and coordinating care across different specialties. This expanded role necessitates ongoing professional development and updated protocols.

### Aim of the project

We are updating the original N-ECCO Consensus Statements. It is essential to reflect the advances in IBD nursing practice, especially considering the increased role of technology and the evolving needs of diverse patient populations. This update should provide a framework for IBD nurses to continue delivering high-quality, evidence-based care while adapting to the changing landscape of healthcare delivery.

The Consensus will follow the Oxford levels of Evidence methodology; however, it will incorporate a PICO-structured approach with systematic literature searches undertaken by a professional librarian.
